  - Ms. Burillo motioned to approve, supported by Mr. Evans, the motion carried.
    - Ayes: 3            Nays: 3            Absent: 1
  - The Permit was not approved due to a tie vote.

#### **DISCUSSION ITEMS:**

- Authorize advertisement for tree trimming and removal bids.
  - The Council approved the request to secure bids.
- Discuss proposed Council Rules, Procedures and Etiquette draft. Consider placing for adoption in December.
  - Ms. Ladner would like to pursue the use of a consent agenda for future meetings. It will cover agenda, minutes, bills/payroll, department reports, correspondence, and board minutes with one motion.
- Discuss the information received from the City Attorney regarding the City's ability/need to declare a local state of emergency to continue permitting virtual/remote public meeting attendance and participation if there are no further changes to PA 228 of 2020.
  - The Council is in favor.

#### **CITY MANAGER'S REPORT:**

- Office employees will be working from home for the foreseeable future. All employees are required to check-in remotely for health screening via the MiSymptoms application.
- Tablets have been purchased for those needing them to remote into meetings.
- City email addresses will be created for board members, and all literature for meetings will be distributed electronically for all meetings.
- Ms. Ladner indicated that she will be out of state as of 12/20 but will be reachable via phone or email.

#### **COMMUNICATIONS FROM THE MAYOR AND COUNCIL:**

- Mayor V. Platt mentioned the need for a Mayor Pro-Tem, Mr. B. Platt nominated Mr. Splane, supported by Ms. Burillo. Mr. Rob Splane will be the new Mayor Pro-Tem.
  - Ayes: 6            Nays: 0            Absent: 1
- Applications for the vacant Council position will be accepted until December 5 so that the position may be filled before the December 8 meeting.
- Ms. Burillo asked about the letter that Mr. George Sadler presented at the last meeting during the public comment portion.
  - Ms. Ladner advised the Council that the City Attorney stated that there was no reason to take action and that the election's results stand.
- Mr. Splane thanked the new members for their interest in the Redevelopment Ready program.
- A list of Boards/Commissions/Committees will be sent out to all Council members, requesting that they choose three that they would like to be a member.
